**Friday 08/07/2022 - Volunteering as an essential element of active citizenship**

- General opening of the event
  - Daily dose of volunteering – presentation of volunteering, its benefits and help at different levels - discussion
  - Volunteering its benefits and assistance at various levels - discussions
  - Let's clean up Europe - Children from the local primary school as well as employees of the village of Hegyeshalom take part in voluntary environmental activity every year
  - Exchange of experience with the use of the institute of European citizenship
  - Cultural program - performances of partners
- At the beginning of the event, after a mutual meeting, the participants will be introduced to the concept of the project, elementary European topics will be taken over. The event will introduce citizens to one of the basic pillars of European citizenship - volunteering.*

**Saturday 09/07/2022- Promotion of intercultural dialogue and mutual understanding**

- Debate of Europe - Forum on intercultural dialogue, providing an opportunity to express views on EU activities in the field of hearing participants
  - "It's about us" - presentation of the participating partners, their culture, history, specifics and uniqueness
  - Performances of successful artists - natives of participating countries
- By focusing on intercultural dialogue, we seek to create connections and common ground between the cultures, communities and people involved by promoting understanding and interaction. The presentation of intercultural dialogue is a challenge for all Europeans to discover the benefits of our rich cultural heritage and to learn from different cultural traditions.*

**Saturday 09/07/2022 - Combating the stigmatization of migrants and minority groups**

- Approach to the situation of migrants in our society
  - Gender equality in society! - unacceptable elements of discrimination
  - Presentation of projects focused on minorities living in the territory of partners - best practices
  - Integration of minority children into the teaching process - examples from practice, how children accepted a new pupil among themselves and how the pupil established himself
- On the next day of the implemented project, emphasis will be placed on the situation of migrants in our society. We often perceive migration through the negative eyepiece that is mediated to us. He is often unaware of the reasons for the migrants' actions. The topic is discussed from a social, economic and political aspect. The presented project fully supports diversity, tolerance and respect for common values.*

**Sunday 10/07/2022 - Solidarity as a fundamental pillar**

- Mechanisms of solidarity within the EU - discussion
  - Active old age - fight against old age diseases and effort to be useful
  - Let's consider our Europe - Environmental policy in terms of environmental protection
  - Social Europe - steps it takes to eliminate social exclusion and poverty in society
  - Legal, political, economic and ethnic limits of European solidarity
- The event will address the topics of Solidarity in times of crisis, social solidarity, intergenerational solidarity, Solidarity from economic and environmental stimuli. An important aspect of the debate will be to emphasize the added value of EU intervention in times of crisis, as demonstrated in the event of a refugee and migration crisis, when national responses appear insufficient, emphasizing the limits of these solidarity mechanisms.*
